Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, gem set, multistone, pendant of hand-assembled construction.

Feature central five claw setting, housing one pear shape amethyst, claw set. One row of twenty-four round brilliant diamonds, frames one side, and curls around the bottom of the central setting. All diamonds are claw set. The pendant is finished with an articulated triangular bail.

Pendant dimensions = 27.00mm (ave. length including bail) x 12.39mm (ave. width) x 7.03mm (ave. depth).

Polished finish.

Stamped "750" - acid tested as 18 carat gold.

The pendant contains:

One claw set pear shaped natural amethyst, colour is "medium dark purple".

Dimensions = 13.20mm(L) x 8.76mm(W) x 5.40mm(D-estimated)

Total Weight = 2.98ct (estimated - see NOTE below)

Twenty Four claw set round brilliant cut diamonds, clarity is "Si", colour is "H to I" (mixed).

Dimensions = 1.30mm(Dia) x 0.79mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.24ct (estimated - see NOTE below)

Total Item Weight = 4.40 grams Total Gemstone Weight = 3.22ct Total Metal Weight = 3.76 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar pendant employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
