## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, 9ct yellow gold and rhodium plated, gem set, dress ring, of cast construction.

Plain, narrow, low half round band of 1.83mm width (at base) x 0.80mm depth, with open back (cut out) settings, and a curved underrail.

Feature central four claw setting, housing one oval natural emerald, claw set. On both sides of the central setting, is two shared claw settings, each housing one round brilliant cut diamond, claw set. The settings are secured between the "split" style shoulders of the plain and polished band. Rhodium plating to the diamond setting areas.

Polished finish.

Stamped '750 18K unknown makers mark' - acid tested as 18 carat gold.

Ring size: M 1/2.

The ring contains:

One claw set oval shaped natural emerald, colour is "green".

Dimensions = 6.15mm(L) x 4.39mm(W) x 2.61mm(D-estimated)

Total Weight = 0.40ct (estimated - see NOTE below)

Four claw set round brilliant cut diamonds, clarity is "P1 & P2" (mixed), colour is "H to I" (mixed).

Dimensions (average) = 1.50mm(Dia) x 0.92mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.04ct (estimated - see NOTE below)

Total Item Weight = 2.56 grams Total Gemstone Weight = 0.44ct Total Metal Weight = 2.47 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
