Valuation for Traditional Retail Insurance Replacement

Item 1

One lady's, hand-assembled raised, 14ct rose gold & diamond set, multistone ring. Plain, wide, low half round, tapered band, measures 3.73mm width (at base) x 1.28mm depth, with cut-out underrail.

Feature, "triple row across the top". Housing eighteen round brilliant cut diamond, claw set. The extended shoulders, taper up to the top, with a brush finish termination, to both sides.

Polished finish. non stamped - acid tested as 14 carat gold. Finger size = P.

The ring contains;

Eighteen claw set round brilliant cut diamonds, clarity is "Si & P1"(mixed), colour is "brown tint", medium cut quality.

Dimensions = 1.50mm (average diameter) x 0.92mm (D-estimated) (smallest)

Dimensions = 1.69mm (average diameter) x 1.03mm (D-estimated) (largest)

Total Weight = 0.25ct (estimated - see NOTE below).

Total Item Weight = 4.30 grams, Total Gemstone Weight = 0.25ct, Total Metal Weight = 4.25 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
