Valuation for Traditional Retail Insurance Replacement

Item 1

One lady's, hand finished, raised 9ct white gold & diamond set, multistone ring. Plain, narrow, low half round, tapered band, measures 3.05mm width (at base) x 1.17mm depth, with cut-out underrail.

Feature, "illusion cluster" ring design. Comprising, a raised four claw setting to top, housing ten round brilliant cut diamonds, illusion claw set. The extended shoulders, tapers up to the top, from both sides. Pointed end terminations, to both shoulder.

Polished finish, stamped "375, JP88" - acid tested as 9 carat gold. Finger size O.

The ring contains;

One illusion claw set round brilliant cut diamond, clarity is "Si", colour is "light brown tint", medium cut quality.
Dimensions = 2.90mm (Diameter) x 1.77mm (D-estimated)
Total Weight = 0.10ct

Twenty One channel set round brilliant cut diamonds, clarity is "SI-P3", colour is "Other-H", medium cut quality.
Dimensions = 1.40mm (average diameter) x 0.85mm (D-estimated) (smallest)
Dimensions = 1.70mm (average diameter) x 1.04mm (D-estimated) (largest)
Total Weight = 0.30ct (estimated - see NOTE below).

Total Item Weight = 3.40 grams, Total Gemstone Weight = 0.40ct, Total Metal Weight = 3.32 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
