Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct white gold, diamond set, multistone, 'cluster' style ring, of hand-assembled construction.

Plain, narrow, low half round band of 1.65mm width (at base) x 1.04mm depth, with hollow top and shoulders, open back settings, and a curved underrail.

Feature 'flower' style cluster, housing nine round brilliant cut diamonds, largest to the centre, claw set. The top plate has an open wire base, and is secured between the extended and square shoulders. Each shoulder houses eight round brilliant cut diamonds, graduating in size and channel set.



Polished finish.

Stamped '9K JP163' - acid tested as 9 carat gold.

Ring size: S.

The ring contains:

One claw set round brilliant cut diamond, clarity is "P1", colour is "H".

Dimensions = 3.96mm(Dia) x 2.42mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.22ct (estimated - see NOTE below)

Twenty Four claw set and channel set round brilliant cut diamonds, clarity is "P1 & P2" (mixed), colour is "H to J" (mixed).

Dimensions = 1.10mm(Dia) x 0.67mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.50mm(Dia) x 1.53mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.65ct (estimated - see NOTE below)

Total Item Weight = 2.90 grams Total Gemstone Weight = 0.87ct Total Metal Weight = 2.73 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
