Valuation for Traditional Retail Insurance Replacement

Item 1

One lady's, hand-assembled raised, 18ct yellow and white gold & diamond set, solitaire ring. Plain, narrow, low half round, tapered band, measures, 1.90mm (at base) x 0.89mm depth, with curved underrail.

Feature, "solitaire style" ring design. Comprising, a raised white gold six claw sett, & partial shoulder on top, houses one (laser inscribed), round rose cut/brilliant cut (mixed), claw set. The extended shoulders, of the yellow gold band tapers up to the top, from both sides.

Polished finish, stamped "750, CG" - acid tested as 18 carat gold.

Finger size = Q.

The ring contains;

One claw set rose cut/brilliant cut diamond (mixed), clarity is "P2", colour is "H", medium cut quality.
Dimensions = 5.84mm (Diameter) x 3.50mm (D-estimated)
Total Weight = 0.60ct (estimated - see NOTE below).

Total Item Weight = 3.80 grams, Total Gemstone Weight = 0.60ct, Total Metal Weight = 3.68 grams (estimated)

NOTE: Limited gemmological testing, inset. The diamond, has been laser inscribed on the girdle "DIAMWAG, symbol? SP 137, however no paper work of certification was presented at the time of this valuation. Due to setting constraints, the exact dimensions of the diamond cannot be ascertained. Therefore, weight of the diamond are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamond, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing, a new round brilliant cut diamond & similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
