Valuation for Traditional Retail Insurance Replacement

Item 1

One, 10ct yellow gold, diamond set, multistone ring, of cast construction.

Plain, narrow, low half round band of 3.71mm width (at base) x 1.23mm depth, with open back (cut out) settings.

Feature one diagonal row of seven round brilliant cut diamonds, spanning across the top plate, varying in size, and channel set. The settings are framed with a panels on both sides and down the shoulders, with a satin finish. The top plate is secured between the shoulders of the plain and polished band.

Polished finish.

Stamped '10K MHJ' - acid tested as 9 carat gold. Ring size: R 1/2.

The ring contains:

Seven channel set round brilliant cut diamonds, clarity is "P1 & P2" (mixed), colour is "H to I" (mixed).

Dimensions = 1.86mm(Dia) x 1.13mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.97mm(Dia) x 1.2mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.19ct (estimated - see NOTE below)

Total Item Weight = 8.27 grams Total Gemstone Weight = 0.19ct Total Metal Weight = 8.23 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
