Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, gemset, multistone, necklet, of cast construction.

Feature round top plate with a six claw setting, housing one round natural tourmaline, to the centre, claw set. Surrounding is one row of fourteen round brilliant cut diamonds, bead set. The settings are enclosed with a decorative pierced plate, to the reverse. The pendant is suspended on a 'flat curb' link style chain. The chain is finished with a small parrot clasp.

Pendant dimensions = 11.13cm (ave. length) x 11.09mm (ave. width) x 7.29mm (ave. depth).

Chain dimensions = 45.00cm (ave. length) x 1.33mm (ave. width).

Polished finish. Stamped '750 PML' - acid tested as 18 carat gold.

The necklet contains:

One claw set round natural tourmaline, colour is "pink".

Dimensions = 6.42mm(L) x 6.38mm(W) x 3.90mm(D-estimated)

Total Weight = 0.88ct (estimated - see NOTE below)

Fourteen bead set round brilliant cut diamonds, clarity is "Vs & Si" (mixed), colour is "G to H" (mixed).

Dimensions (average) = 1.75mm(Dia) x 1.07mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.31ct (estimated - see NOTE below)

Total Item Weight = 5.98 grams Total Gemstone Weight = 1.19ct Total Metal Weight = 5.74 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar necklet employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
