Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct white gold, diamond set, multistone, 'cluster' style ring, of cast construction.

Plain, narrow, low half round, tapered band of 1.72mm width (at base) x 1.05mm depth, with an open back settings, and a curved underrail.

Feature central round illusion plate within a four claw setting, housing one round brilliant cut diamond, to the centre, claw set. Surrounding is one row of nine round brilliant cut diamonds, varying in size, and bead set. The top plate is secured in between the extended and pointed shoulders, of the plain and polished band.

Polished finish.

Stamped '375 JP150' - acid tested as 9 carat gold.

Ring size: M.

The ring contains:

One claw set round brilliant cut diamond, clarity is "P2", colour is "J".

Dimensions = 2.39mm(Dia) x 1.46mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.05ct (estimated - see NOTE below)

Nine bead set round brilliant cut diamonds, clarity is "P1 & P2" (mixed), colour is "I to J" (mixed).

Dimensions = 0.90mm(Dia) x 0.55mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.00mm(Dia) x 0.61mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.05ct (estimated - see NOTE below)

Total Item Weight = 2.14 grams Total Gemstone Weight = 0.10ct Total Metal Weight = 2.12 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
