Valuation for Traditional Retail Insurance Replacement

Item 1

One, 10ct rose gold, gem set, multistone, necklet, of hand-assembled construction.

Feature cushion shaped top plate with a central four claw setting, housing one cushion shaped natural morganite, claw set. Surrounding is one row of sixteen round brilliant cut diamonds, claw set. The gallery has a pierced decorative 'scroll' pattern, and the setting is enclosed with a pierced panel, to the reverse. The pendant is finished with an articulated tapered bail. The pendant is suspended on a fine oval link chain, which is finished with a small bolt ring.



Chain dimensions = 46.50cm (ave. length) x 0.93mm (ave. width).

Pendant Dimensions = 16.20mm (ave. length) x 9.96mm (ave. width) x 5.29mm (ave. depth).

Polished finish.

Stamped 'NC 10K MHJ' - acid tested as 9 carat gold.

The necklet contains:

One claw set square cushion natural morganite, colour is "pink".

Dimensions = 6.03mm(L) x 6.02mm(W) x 3.91mm(D-estimated)

Total Weight = 0.93ct (estimated - see NOTE below)

Sixteen bead set round brilliant cut diamonds, clarity is "Si & P1" (mixed), colour is "G to H" (mixed).

Dimensions = 1.55mm(Dia) x 0.95mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.76mm(Dia) x 1.07mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.30ct (estimated - see NOTE below)

Total Item Weight = 2.22 grams Total Gemstone Weight = 1.23ct Total Metal Weight = 1.97 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar necklet employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
