## Valuation for Traditional Retail Insurance Replacement

### Item 1

One pair of, 18ct white gold, diamond set, multistone, clip-back drop earrings, of hand-assembled construction.

Feature 'cluster' style earrings, with a central four claw setting, housing one round brilliant cut diamond, claw set. Surrounding is one row of eleven round brilliant cut diamonds, claw set. Part of the hook, to the top of the earring, also houses one row of eight round brilliant cut diamonds, claw set. The earrings are finished with hook and clip attachments.

Earring dimensions = 17.20mm (ave. length) x 6.85mm (ave. width) x 3.18mm (ave. depth).

Polished finish.

Stamped '750' - acid tested as 18 carat gold.

The earrings contain:

Two claw set round brilliant cut diamonds, clarity is "Vs", colour is "H".

Dimensions = 4.03mm(L) x 4.01mm(W) x 2.43mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.48ct (estimated - see NOTE below)

Thirty Eight claw set round brilliant cut diamonds, clarity is "Vs & Si" (mixed), colour is "H".

Dimensions (average) = 1.34mm(Dia) x 0.82mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.42ct (estimated - see NOTE below)

Total Item Weight = 2.18 grams Total Gemstone Weight = 0.90ct Total Metal Weight = 2.00 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar pair of earrings employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
