Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand finished, 15ct rose gold, multistone, gem set ring.

Plain, narrow, tapered band of 2.11mm in width (at base) x 0.95mm depth, with open back settings.

Feature multi-claw ring design, housing three round cut and faceted synthetic rubies, tapering in size. Alternating with two old cut diamonds, all claw set. The settings having a pierced 'star' design to the sides, all secured between the single 'bevelled' collar style shoulder terminations of the plain and polished band.



Polished finish - stamped '15 with Australian assay marks' - acid tested as approximately 15 carat gold. Finger size is O 1/2.

The ring contains:

Three claw set round cut and faceted synthetic rubies, colour 'medium dark red'.

Dimensions = 3.48mm(Dia) x 2.26mm(D-estimated) (smallest)

Dimensions = 4.50mm(Dia) x 2.56mm(D-estimated) (largest)

Total Weight = 0.85ct (estimated - see NOTE below)

Two claw set old cut diamonds, clarity 'P1', colour 'I to J' (mixed).

Dimensions (average) = 2.28mm(L) x 2.21mm(W) x 1.48mm(D-estimated)

Total Weight = 0.10ct (estimated - see NOTE below)

Total Item Weight = 3.32 grams - Total Gemstone Weight = 0.95ct - Total Metal Weight = 3.13 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring using all modern round brilliant cut diamonds of the same estimated weight, colour and clarity employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
