Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct yellow gold, diamond set, 'three stone' style ring, of cast construction.

Plain, narrow, low half round, tapered band of 2.92mm width (at base) x 1.11mm depth, with open back (cut out) settings.

Feature central raised square top plate, with a decorative four claw setting, housing one round brilliant cut diamond, claw set. The setting is secured between the shoulders of the plain and polished band. Each of the shoulders is embellished with a four claw setting, each housing one round brilliant cut diamond, claw set.

Polished finish. Unstamped - acid tested as approximately 9 carat gold. Ring size: M 1/2.

The ring contains:

One claw set round brilliant cut diamond, clarity is "Si1", colour is "H".

Dimensions = 3.41mm(L) x 3.37mm(W) x 1.90mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.14ct (estimated - see NOTE below)

Two claw set round brilliant cut diamonds, clarity is "P1 & P2" (mixed), colour is "J to K" (mixed).

Dimensions = 2.20mm(Dia) x 1.34mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.60mm(Dia) x 1.59mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.11ct (estimated - see NOTE below)

Total Item Weight = 4.71 grams Total Gemstone Weight = 0.25ct Total Metal Weight = 4.66 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
