Valuation for Traditional Retail Insurance Replacement

Item 1

One, 14ct yellow gold, gem set, pendant, of hand-assembled construction.

Feature oval 'cluster' style pendant, with a central four claw setting, housing one oval natural emerald, claw set. Surrounding is one row of round brilliant cut diamonds, claw set. Radiating out from the central setting, are twelve pear shaped natural emeralds, claw set. In between these settings are round brilliant cut diamonds, bead set. The pendant is finished with an articulated tapered bail, embellished with three round brilliant diamonds, bead set. There are a total of sixty-nine round brilliant cut diamonds.



Pendant dimensions = 27.00mm (ave. length) x 19.12mm (ave. width) x 7.69mm (ave. depth).

Polished finish. Stamped '14K EFFY' - acid tested as 14 carat gold.

The pendant contains:

One claw set oval shaped natural emerald, colour is "green".

Dimensions = 8.19mm(L) x 6.2mm(W) x 4.25mm(D-estimated)

Twelve claw set pear shaped natural emeralds, colour is "green".

Sixty Nine bead set round brilliant cut diamonds, clarity is "Vs & Si" (mixed), colour is "H to I" (mixed).

Dimensions = 1.21mm(Dia) x 0.74mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.41ct (estimated - see NOTE below)

Total Item Weight = 4.75 grams Total Gemstone Weight = 3.56ct Total Metal Weight = 4.04 grams (estimated)

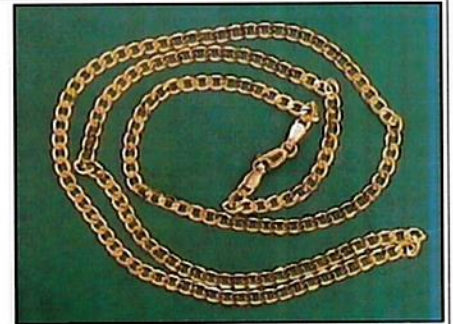
