Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct yellow gold and rhodium plated, gem set, 'cluster' style ring, of cast construction.

Plain, narrow, low half round band of 2.06mm width (at base) x 0.96mm depth, with open back settings, and a curved underrail.

Feature central four claw setting, housing one oval glass (paste) type material, claw set. Surrouding is two rows of fourteen round brilliant cut diamonds, claw set. The top plate is secured to the underrail, and in between the 'tri-split' style shoulders, of the plain and polished band. Rhodium plating to the top plate.



Polished finish. Stamped '375' - acid tested 9 carat gold. Ring size: Q.

The ring contains:

One claw set oval shaped glass, colour is "green".

Dimensions = 8.08mm(L) x 5.98mm(W) x 4.12mm(D-estimated)

Total Weight = 1.13ct (estimated - see NOTE below)

Twety Eight claw set round brilliant cut diamonds, clarity is "Vs & Si" (mixed), colour is "H to I" (mixed).

Dimensions = 2.00mm(Dia) x 1.22mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.15mm(Dia) x 1.31mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.94ct (estimated - see NOTE below)

Total Item Weight = 3.47 grams Total Gemstone Weight = 2.07ct Total Metal Weight = 3.06 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only.
