Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, diamond set, multistone ring, of cast construction.

Plain, narrow, low half round band of 1.73mm width (at base) x 0.94mm depth, with open back (cut out) settings.

Feature one row of six baguette cut diamonds, spanning across the top of the band, channel set. One of the sides of the band is embellished with one row of eleven round brilliant cut diamonds, bead set. The settings are framed with millegrain detail. There is a curve in the centre of the band. The settings are secured between the shoulders of the plain and polished band.

Polished finish. Stamped 'PL 750 RENATO D0.42' - acid tested as 18 carat gold. Ring size: L.

The ring contains:

Six channel set baguette cut diamonds, clarity is "Vs", colour is "G".

Dimensions (average) = 3.50mm(L) x 1.40mm(W) x 1.02mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.26ct (estimated - see NOTE below)

Eleven bead set round brilliant cut diamonds, clarity is "Si", colour is "G".

Dimensions (average) = 1.45mm(Dia) x 0.87mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.16ct (estimated - see NOTE below)

Total Item Weight = 2.68 grams Total Gemstone Weight = 0.42ct Total Metal Weight = 2.60 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
