Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct white gold, multistone, gem set ring, of cast construction.

Plain, narrow, tapered band of 2.24mm in width (at base) x 1.12mm depth, with hollow top and shoulders, and open back settings.

Feature 'cross-over' style ring design, having one tapering row, housing seven round brilliant cut diamonds, tapering in size, claw set.

Polished finish - stamped '375 JP88' - acid tested as 9 carat gold. Finger size is O.



The ring contains:

Three claw set round brilliant cut diamonds, clarity 'Si', colour 'I to J' (mixed).

Dimensions = 2.18mm(Dia) x 1.33mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.55mm(Dia) x 1.56mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.14ct (estimated - see NOTE below)

Four claw set round brilliant cut diamonds, clarity 'Si', colour 'I to J' (mixed).

Dimensions = 1.00mm(Dia) x 0.61mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.85mm(Dia) x 1.13mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.07ct (estimated - see NOTE below)

Total Item Weight = 1.78 grams - Total Gemstone Weight = 0.21ct - Total Metal Weight = 1.74 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
