Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand-assembled, 18ct yellow gold and 18ct white gold, multistone, gem set ring.

Plain, narrow, tapered band of 2.42mm in width (at base) x 1.03mm depth.

Feature central white gold, four 'corner' claw settings, housing four Princess cut diamonds in each, largest to the centre, all invisible set. Secured between the shoulders of the yellow gold plain and polished band.

Polished finish.

Stamped '750 CG' - acid tested as 18 carat gold.

Finger size is R.

The ring contains:

Twelve invisible set Princess cut diamonds, clarity 'Si & P1' (mixed), colour 'I to J' (mixed).

Dimensions = 1.72mm(L) x 1.70mm(W) x 1.00mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.20mm(L) x 2.18mm(W) x 1.30mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.50ct (estimated - see NOTE below)

Total Item Weight = 4.51 grams

Total Gemstone Weight = 0.50ct

Total Metal Weight = 4.41 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
