## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, 14ct white gold, three diamond set ring, of cast construction.

Plain, narrow, tapered band of 1.18mm in width (at base) x 0.90mm depth, with a curved and split underrail.

Feature shared claw railed settings, each housing one round brilliant cut diamond, slightly tapering in size, claw set. Secured between the extended shoulders of the plain and polished band.

Polished finish.

Stamped '14K' - acid tested as 14 carat gold.

Finger size is Q.

The ring contains:

Three claw set round brilliant cut diamonds, clarity 'P1 & P2' (mixed), colour 'K to M' (mixed).

Dimensions = 4.45mm(Dia) x 2.71mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 4.50mm(Dia) x 2.75mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 1.00ct (estimated - see NOTE below)

Total Item Weight = 2.68 grams

Total Gemstone Weight = 1.00ct

Total Metal Weight = 2.48 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
