Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, gem set, multistone ring, of hand-assembled construction.

Plain, narrow, flat, tapered band of 2.93mm width (at base) x 0.73mm depth, with open back (cut out) settings.

Feature five, four claw settings, housing three square cut natural rubies, alternating with two round brilliant cut diamonds, spanning across the top of the band, claw set. The settings are secured between the shoulders of the plain and polished band.



Polished finish. Stamped 18CT PALL unknown makers mark' - acid tested as 18 carat gold.

Ring size: T.

The ring contains:

Two claw set round brilliant cut diamonds, clarity is "Si1", colour is "H".

Dimensions (average) = 2.10mm(Dia) x 1.28mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.07ct (estimated - see NOTE below)

Three claw set square natural rubies, colour is "red".

Dimensions (average) = 2.55mm(L) x 2.55mm(W) x 1.56mm(D-estimated)

Total Weight = 0.33ct (estimated - see NOTE below)

Total Item Weight = 3.66 grams Total Gemstone Weight = 0.40ct Total Metal Weight = 3.58 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
