Fabricated from 18 carat yellow gold.

Four round brilliant cut or single cut diamonds, to each link, bead set.

Rhodium plating to the diamond setting areas.

Constructed by machine and assembled.

Of 'curb' style linkage in a 'filed' design.

Medium-size "box" style clasp attached.

With a safety chain, and two figure 8 safety catches.

Polished finish.

Stamped '18K 750 P' - acid tested as 18 carat gold.

Bracelet dimensions = 19.6cm (length) x 8.08mm (width) x 2.57mm (depth).

One Hundred And Twenty Nine bead set round brilliant cut and single cut diamonds, clarity is "Si & P1 & P2" (mixed), colour is "H to J" (mixed).

Dimensions (average) = 1.52mm(Dia) x 0.93mm(D-estimated) x 2%(Girdle Thickness) Total Weight = 1.94ct (estimated - see NOTE below)

Total Item Weight = 34.35 grams Total Gemstone Weight = 1.94ct

Total Metal Weight = 33.96 grams (estimated)
