Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, diamond set, multistone, 'cluster' style ring, of cast construction.

Plain, narrow, low half round, tapered band of 3.41mm width (at base) x 1.55mm depth, with open back settings.

Feature round top plate within a six claw setting, housing one central round brilliant cut diamond, claw set. Surrounding is one row of ten round brilliant cut diamonds, bead set. The setting is secured between the extended and pointed shoulders, of the plain and polished band.



Polished finish.

Stamped '18K 0.50CT 279764532' - acid tested 18 carat gold.

Ring size: O.

The ring contains:

One claw set round brilliant cut diamond, clarity is "P2", colour is "H".
Dimensions = 4.05mm(Dia) x 2.56mm(D-estimated) x 2%(Girdle Thickness)
Total Weight = 0.26ct (estimated - see NOTE below)

Ten bead set round brilliant cut diamonds, clarity is "Si & P1 & P2" (mixed), colour is "H".
Dimensions (average) = 1.90mm(Dia) x 1.16mm(D-estimated) x 2%(Girdle Thickness)
Total Weight = 0.24ct (estimated - see NOTE below)

Total Item Weight = 5.09 grams Total Gemstone Weight = 0.50ct Total Metal Weight = 4.99 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
