One bangle.

Fabricated from 18ct yellow gold.

Of hollow construction.

Of hinged 'slave' design.

Of oval shape.

Flat outer top profile, embellished with engraved detail.

One row of twenty, four claw settings, spanning across the top of the front panel, each housing one round or oval natural peridot, slightly graduating in size, largest to the centre, and claw set.

Bangle dimensions = 58.00mm (ave. length) x 54.00mm (ave. width) x 2.71mm (ave. depth).

Polished finish.

Unstamped - acid tested and x-rayed as approximately 18 carat gold.

Twenty claw set round and oval natural peridots, colour is "green".

Dimensions = 4.76mm(L) x 4.03mm(W) x 3.2mm(D-estimated) (smallest)

Dimensions = 5.76mm(L) x 5.53mm(W) x 2.99mm(D-estimated) (largest)

Total Weight = 9.00ct (estimated - see NOTE below)
