Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold and platinum, 'three stone' style ring, of hand-assembled construction.

Plain, narrow, half round band of 1.68mm width (at base) x 1.24mm depth, with open back settings, and a curved underrail.

Feature square decorative top plate, housing one round brilliant cut diamond, bead set. Either side of the central setting is one smaller square top plate, each housing one single cut diamond, bead set. The top plates are supported with a pierced filigree gallery. The settings and shoulder detail, are platinum tipped, and are secured between the shoulders of the plain and polished yellow gold band.

Polished finish.

Unstamped - acid tested as approximately 18 carat gold.

Ring size: O 1/2.

The ring contains:

- One bead set round brilliant cut diamond, clarity is "Si1", colour is "G".
Dimensions = 3.12mm(Dia) x 1.87mm(D-estimated) x 2%(Girdle Thickness)
Total Weight = 0.11ct (estimated - see NOTE below)
- Two bead set single cut diamonds, clarity is "Si", colour is "H".
Dimensions (average) = 1.86mm (diameter)
Total Weight = 0.05ct (estimated - see NOTE below)

Total Item Weight = 2.60 grams Total Gemstone Weight = 0.16ct Total Metal Weight = 2.57 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
