Valuation for Traditional Retail Insurance Replacement

Item 1

One, platinum, diamond set, multistone ring, of hand-assembled construction.

Plain, narrow, low half round, tapered band of 2.11mm width (at base) x 0.95mm depth, with hollow top and shoulders, open back settings, and curved underrail.

Feature central decorative four claw setting, housing one round brilliant cut diamond, claw set. The setting is secured between the extended and square shoulders, of the plain and polished band. Each of the shoulders houses two rows of seven round brilliant cut diamonds, claw set.

Polished finish.

Stamped 'DZ Pt950 D0.75ct d0.108ct' - acid tested as platinum.

Feature one row of nineteen round brilliant cut diamonds, spanning across the top of the band, slightly varying in size, and claw set. The settings are secured between the shoulders of the plain and polished band.
