Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, diamond set, multistone ring, of hand-assembled construction.

Plain, narrow, flat, tapered band of 3.21mm width (at base) x 0.87mm depth.

Feature square top plate, housing one old cut diamond, claw set. Each of the tapered shoulder plates houses two old cut diamonds, graduating in size, and bead set. The settings are finished millegrain detail and secured to the top of the plain and polished band.

Polished finish.

Stamped 'GB 750 F5' - acid tested a 18 carat gold.

Ring size: O 1/2.

The ring contains:

One claw set old cut diamond, clarity is "P1", colour is "J".

Dimensions = 2.94mm(L) x 2.80mm(W) x 1.71mm(D-estimated)

Total Weight = 0.09ct (estimated - see NOTE below)

Four bead set old cut diamonds, clarity is "Si", colour is "H to K" (mixed).

Dimensions = 2.05mm(L) x 2.05mm(W) x 1.25mm(D-estimated) (smallest)

Dimensions = 2.50mm(L) x 2.50mm(W) x 1.53mm(D-estimated) (largest)

Total Weight = 0.18ct (estimated - see NOTE below)

Total Item Weight = 4.32 grams Total Gemstone Weight = 0.27ct Total Metal Weight = 4.27 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
