Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct white gold, gem set, multistone ring, of cast construction.

Plain, narrow, low half round, tapered band of 1.61mm width (at base) x 1.02mm depth, with a hollow top and shoulders, and open back settings.

Feature two rows of twenty-five round brilliant cut diamonds, spanning across the top of the band, claw set. The settings are secured between the shoulders of the plain and polished band. There are two round cut corundum material, to the inside of the band, gypsy set.

Polished finish.

Stamped '9K VM' - acid tested as 9 carat gold.

Ring size: T.

The ring contains:

Fifty claw set round brilliant cut diamonds, clarity is "P1 & P2" (mixed), colour is "G to H" (mixed).

Dimensions = 1.00mm(Dia) x 0.61mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.10mm(Dia) x 0.67mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.35ct (estimated - see NOTE below)

Two gypsy set round corundum material, colour is "red and blue".

Dimensions (average) = 0.84mm(Dia) x 0.51mm(D-estimated)

Total Weight = 0.01ct (estimated - see NOTE below)

Total Item Weight = 2.16 grams Total Gemstone Weight = 0.36ct Total Metal Weight = 2.09 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
