Valuation for Traditional Retail Insurance Replacement

Item 1

One, 10ct yellow gold and rhodium plated, gem set, multistone, flexible link bracelet, of hand-assembled construction.

Feature alternating 'flower' clusters, each housing seven round brilliant cut diamonds, claw set, with one row of five baguette cut diamonds, channel set. There are a total of one hundred and twelve round brilliant cut diamonds, and eighty baguette cut diamonds. The bracelet is finished with a box clasp, and a figure 8 safety catch, and a safety chain. Rhodium plating to the diamond setting areas.



Bracelet dimensions = 18.00cm (ave. length) x 7.55mm (ave. width) x 4.95mm (ave. depth).

Polished finish. Stamped '10K M' - acid tested as 9 carat gold.

The bracelet contains:

One Hundred And Twelve claw set round brilliant cut diamonds, clarity is "P1 to P2" (mixed), colour is "I to light tinted brown".

Dimensions = 1.50mm(Dia) x 0.92mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.80mm(Dia) x 1.10mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 2.20ct (estimated - see NOTE below)

Eighty channel set baguette cut diamonds, clarity is "Si & P1 & P2" (mixed), colour is "I to J" (mixed).

Dimensions (average) = 2.20mm(L) x 0.96mm(W) x 0.70mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.80ct (estimated - see NOTE below)

Total Item Weight = 16.01 grams Total Gemstone Weight = 3.00ct Total Metal Weight = 15.40 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar bracelet employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
