Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, gem set, 'cluster' style ring, of cast construction.

Plain, narrow, low half round, tapered band of 1.70mm width (at base) x 1.07mm depth, with open back settings, and a curved underrail.

Feature central bezel setting, housing one round brilliant cut diamond, bezel set. Surrounding is one row of twenty round brilliant cut diamonds, claw set. The top plate is secured to the underrail, and in between extended and square shoulders, of the plain and polished band. Each of the shoulders houses one row of six round brilliant cut diamonds, graduating in size, and channel set



Polished finish. Stamped '750 2 unknown makers mark' - acid tested as 18 carat gold. Ring size: M.

The ring contains:

One bezel set round brilliant cut diamond, clarity is "Si2", colour is "E".

Dimensions = 4.78mm(L) x 4.76mm(W) x 2.89mm(D-estimated) x 3.5%(Girdle Thickness)

Total Weight = 0.40ct (known weight - see NOTE below)

Thirty Two channel set round brilliant cut diamonds, clarity is "Si", colour is "G to I" (mixed).

Dimensions = 0.85mm(Dia) x 0.52mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.75mm(Dia) x 1.07mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.22ct (estimated - see NOTE below)

Total Item Weight = 3.14 grams Total Gemstone Weight = 0.62ct Total Metal Weight = 3.02 grams (estimated)

NOTE: The diamond has been accompanied with a diamond certificate by Messrs. Gemological Institute of America (GIA) Certificate number: 2217858908 Dated: February 20, 2016. The certificate indicates the diamond has been laser inscribed upon the girdle with GIA (logo) and 2217858908. Due to setting constraints, the Australian Gem Testing Laboratory are unable to view or confirm the inscription, or the exact dimensions of the diamond cannot be ascertained. Therefore, weight of the diamond is very much an estimation. For confirmation of the inscription, and an accurate weight, colour, and clarity grading, the diamond requires removal from the setting. The below replacement figure is based upon crafting a similar necklet employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.


