Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand-assembled, 18ct white gold, multistone, gem set ring.

Plain, narrow, tapered band of 2.17mm in width (at base) x 1.44mm depth, with closed back settings.

Feature six individual four claw railed settings, each housing one round brilliant cut diamond, claw set. Secured between the 'cross-over' style shoulders of the plain and polished band.

Polished finish.

Stamped '18K' - acid tested as 18 carat gold.

Finger size is P.

The ring contains:

Six claw set round brilliant cut diamonds, clarity 'Vs & Si' (mixed), colour 'G to H' (mixed).
Dimensions (average) = 2.70mm(Dia) x 1.65mm(D-estimated) x 2%(Girdle Thickness)
Total Weight = 0.42ct (estimated - see NOTE below)

Total Item Weight = 6.00 grams
Total Gemstone Weight = 0.42ct
Total Metal Weight = 5.91 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
