Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand assembled 18ct yellow and 18ct white gold and rhodium plated, multi-stone, ring set, of cast construction.

The set comprising a 18ct yellow gold and 18ct white gold diamond set engagement ring with a matching 18ct yellow gold diamond set wedding ring. Each ring having a plain, narrow, low half round, tapered band with a combined basal width of 3.24mm x 1.18mm in depth.

The engagement ring has a white gold four claw setting, housing one Princess cut diamond, claw set. The setting is secured to the underrail, and in between the extended and pointed shoulders of the plain and polished yellow gold band. The matching wedding ring has one row of seven Princess cut diamonds, alternating with eight baguette cut diamonds, spanning across the top of the band, and channel set. Rhodium plating to the settings areas. The wedding ring sits alongside the engagement ring above.



Polished finish. Stamped '18ct 750 MHJ' - acid tested as 18 carat gold. Ring size: J.

The ring contains:

One claw set Princess cut diamond, clarity is "Si2", colour is "J".
Dimensions = 5.52mm(L) x 5.51mm(W) x 3.85mm(D-estimated) x 2%(Girdle Thickness)
Total Weight = 1.00ct (estimated - see NOTE below)

Seven channel set Princess cut diamonds, clarity is "Si & P1" (mixed), colour is "G to H" (mixed).
Dimensions (average) = 2.00mm(L) x 2.00mm(W) x 1.42mm(D-estimated) x 2%(Girdle Thickness)
Total Weight = 0.34ct (estimated - see NOTE below)

Eight channel set baguette cut diamonds, clarity is "Vs & Si" (mixed), colour is "G to H" (mixed).
Dimensions (average) = 2.00mm(L) x 1.35mm(W) x 0.99mm(D-estimated) x 2%(Girdle Thickness)
Total Weight = 0.16ct (estimated - see NOTE below)

Total Item Weight = 5.67 grams Total Gemstone Weight = 1.50ct Total Metal Weight = 5.37 grams (estimated)

NOTE: The diamond has been certified by Messrs. Australian Diamond Grading Laboratory Certificate number: H01004. The diamond has also been laser inscribed upon the girdle with ADGL (logo) and michael hill. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
