Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand-assembled, 18ct yellow gold and white gold, multistone, gem set ring.

Plain, narrow, tapered band of 2.73mm in width (at base) x 0.97mm depth.

Feature central yellow gold four claw setting, housing one round cut and faceted natural emerald, claw set. To each shoulder is a three 'leaf' style white gold setting design, bead set with three single cut diamonds. All mounted atop the yellow gold plain and polished band.

Polished finish - stamped '18CT' - acid tested as approximately 18 carat gold. Finger size is Q 1/2.

The ring contains:

One claw set round cut and faceted natural emerald, colour 'medium dark green'.

Dimensions = 4.82mm(Dia) x 2.85mm(D-estimated)

Total Weight = 0.35ct (estimated - see NOTE below)

Six bead set single cut diamonds, clarity 'Si & P1' (mixed), colour 'H to I' (mixed).

Dimensions = 1.15mm (ave. diameter)

Total Weight = 0.05ct (estimated - see NOTE below)

Total Item Weight = 5.07 grams - Total Gemstone Weight = 0.40ct - Total Metal Weight = 4.99 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
