## Valuation for Traditional Retail Insurance Replacement

### Item 1

One pair of, 9ct white gold, gem set, stud earrings, of hand-assembled construction.

Feature central illusion setting, housing one round brilliant cut diamond, illusion set. Surrounding is one floating row of fourteen single cut diamonds, claw set. The earrings are finished with post and butterfly attachments.

Earring dimensions = 6.31mm (ave. length) x 6.31mm (ave. width) x 4.05mm (ave. depth).

Polished finish.

Stamped '9K 375' - acid tested as 9 carat gold.

The item contains:

Two illusion set round brilliant cut diamonds, clarity is "P2", colour is "G".

Dimensions (average) = 2.29mm(Dia) x 1.40mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.10ct (estimated - see NOTE below)

Twenty Eight claw set single cut diamonds, clarity is "Si & P1" (mixed), colour is "G to H" (mixed).

Dimensions (average) = 1.00mm (diameter)

Total Weight = 0.14ct (estimated - see NOTE below)

Total Item Weight = 1.22 grams Total Gemstone Weight = 0.24ct Total Metal Weight = 1.17 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar pair of earrings employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
