## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, 10ct yellow gold, gem set, multistone ring, of hand-assembled construction.

Plain, narrow, low half round, tapered band of 3.19mm width (at base) x 1.33mm depth, with a hollow top and shoulders, open back settings, and a curved cut out underrail.

Feature six row of round brilliant cut diamonds, spanning across the top of the band. There are a total of one hundred and fifty-seven round brilliant cut diamonds. The settings are secured between the tapering shoulders, of the plain and polished band.

Polished finish.

Stamped '10K 1.50 TDW michael hill' - acid tested as approximately 10 carat gold.

Ring size: O 1/2.

The ring contains:

- One Hundred And Fifty Seven pave set round brilliant cut diamonds, clarity is "P1 & P2" (mixed), colour is "H".
- Dimensions = 1.30mm(Dia) x 0.79mm(D-estimated) x 2%(Girdle Thickness) (smallest)
- Dimensions = 1.40mm(Dia) x 0.85mm(D-estimated) x 2%(Girdle Thickness) (largest)
- Total Weight = 1.50ct (estimated - see NOTE below)

Total Item Weight = 4.20 grams  
Total Gemstone Weight = 1.50ct  
Total Metal Weight = 3.92 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
