Valuation for Traditional Retail Insurance Replacement

Item 1

One, 14ct rose gold, gem set, 'solitaire' style ring, of hand-assembled construction.

Plain, narrow, low half round band of 3.06mm width (at base) x 1.50m depth, with a curved underrail.

Feature central six claw setting, housing one round brilliant cut diamond, claw set. The setting is secured to the underrail, and in between the extended and pointed 'split' style shoulders, of the plain and polished band.

Polished finish.

Stamped '14K' - acid tested as 14 carat gold.

Ring size: F.

The ring contains:

One claw set round brilliant cut diamond, clarity is "P1", colour is "G".
Dimensions = 5.69mm(Dia) x 3.47mm(D-estimated) x 3%(Girdle Thickness)
Total Weight = 0.69ct (estimated - see NOTE below)

Total Item Weight = 3.42 grams
Total Gemstone Weight = 0.69ct
Total Metal Weight = 3.28 gams (estimated)



NOTE: The diamond has been inscribed upon the girdle with WGK 2D3EA501. No diamond certificate or paperwork was presented at the time of this valuation. Due to setting constraints, the exact dimensions of the gemstone cannot be ascertained. Therefore, weight of the gemstone is very much an estimation. For an accurate weight, colour, and clarity grading, the gemstone requires removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
