Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct white gold, gem set, 'cluster' style ring, of hand-assembled construction.

Plain, narrow, low half round band of 2.41mm width (at base) x 1.28mm depth, with a curved underrail.

Feature cushion shaped top plate, with a central multi-claw setting, housing one round brilliant cut diamond, claw set. Surrounding is two rows with a total of twenty-four round brilliant cut diamonds, varying in size, and claw set. The top plate is secured between the extended and square shoulders, of the plain and polished band.



Polished finish. Stamped '375 unknown makers mark' - acid tested as 9 carat gold. Ring size: O.

The ring contains:

Five invisibly and claw set round brilliant cut diamonds, clarity is "Si & P1" (mixed), colour is "G to H" (mixed).

Dimensions = 2.18mm(Dia) x 1.33mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 3.28mm(Dia) x 2.00mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.30ct (estimated - see NOTE below)

Twenty Four claw set round brilliant cut diamonds, clarity is "P1 & P2" (mixed), colour is "G to H" (mixed).

Dimensions = 1.30mm(Dia) x 0.79mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.70mm(Dia) x 1.04mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.30ct (estimated - see NOTE below)

Total Item Weight = 3.52 grams Total Gemstone Weight = 0.60ct Total Metal Weight = 3.40 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
