Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, gem set, 'cluster' style ring, of hand-assembled construction.

Plain, narrow, low half round, tapered band of 3.09mm width (at base) x 1.57mm depth, with a hollow top and shoulders, open back settings, and a curved cut out underrail.

Feature cushion shaped top plate, with a central four claw setting, housing one Princess cut diamond, claw set. Surrounding is two rows with a total of forty-four round brilliant cut diamonds, claw set. The top plate is secured between the tapering shoulders, of the plain and polished band. Each of the shoulders houses one inner row of eight baguette cut diamonds, channel set, and two outer rows of nine round brilliant cut diamonds, claw set.



Polished finish. Stamped '750 illegible stamp' - acid tested as 18 carat gold. Ring size: P.

The ring contains:

One claw set Princess cut diamond, clarity is "Vs1", colour is "E".

Dimensions = 3.85mm(L) x 3.68mm(W) x 2.59mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.31ct (known weight - see NOTE below)

Sixteen channel set baguette cut diamonds, clarity is "Vs & Si" (mixed), colour is "G".

Dimensions = 2.10mm(L) x 1.15mm(W) x 0.84mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 3.00mm(L) x 1.45mm(W) x 1.06mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.48ct (estimated - see NOTE below)

Eighty claw set round brilliant cut diamonds, clarity is "Si & P1 & P2" (mixed), colour is "G".

Dimensions = 1.00mm(Dia) x 0.61mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.10mm(Dia) x 0.67mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.41ct (estimated - see NOTE below)

Total Item Weight = 8.10 grams Total Gemstone Weight = 1.20ct Total Metal Weight = 7.86 grams (estimated)

NOTE: The diamond has been certified by Messrs. Gemological Institute of America (GIA) Certificate number: 6425558044 Dated: March 09, 2022. The diamond has also been laser inscribed upon the girdle with GIA (logo) and 6425558044. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.


