Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold and rhodium plated, gem set, pendant, of hand-assembled construction.

Feature decorative pendant, with a diamond shaped domed cluster of sixty-four shared claw settings, to the centre, each housing one round brilliant cut diamond, claw set. The cluster is embellished with ornate elements to the top and bottom, housing a further thirty round brilliant cut diamonds, varying in size, and claw set. The pendant is finished with an articulated tapered bail. Rhodium plating to the diamond setting areas.

Pendant dimensions = 45.00mm (ave. length) x 26.00mm (ave. width) x 2.02mm (ave. depth).

Polished finish.

Stamped '750 * illegible stamps D 1.36ct' - acid tested as 18 carat gold.

The pendant contains:

Ninety Four claw set round brilliant cut diamonds, clarity is "Vs & Si & P1" (mixed), colour is "H to L" (mixed).

Dimensions = 1.49mm(Dia) x 0.91mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.58mm(Dia) x 0.96mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 1.36ct (estimated - see NOTE below)

Total Item Weight = 5.99 grams

Total Gemstone Weight = 1.36ct

Total Metal Weight = 5.73 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar pendant employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
