## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, hand-assembled, 9ct white gold, cluster style, gem set ring.

Plain, narrow soft 'knife-edge' profile, tapered band of 2.31mm in width ( at base) x 1.54mm depth.

Feature six claw setting, consisting of a cluster plate, housing six round brilliant cut diamonds, one to the centre, claw set. The outer row alternating with five round brilliant cut diamonds (smallest), also claw set. Secured between the shoulders of the plain and polished band.

Polished finish - stamped '375 JP02' - acid tested as 9 carat gold. Finger size is S.

The ring contains:

Six claw set round brilliant cut diamonds, clarity 'P1 & P2' (mixed), colour 'H to J' (mixed).  
Dimensions (average) = 2.95mm(Dia) x 1.8mm(D-estimated) x 2%(Girdle Thickness)  
Total Weight = 0.60ct (estimated - see NOTE below)

Five claw set round brilliant cut diamonds, clarity 'Si & P1' (mixed), colour 'H'.  
Dimensions (average) = 1.20mm(Dia) x 0.73mm(D-estimated) x 2%(Girdle Thickness)  
Total Weight = 0.04ct (estimated - see NOTE below)

Total Item Weight = 4.80 grams - Total Gemstone Weight = 0.64ct - Total Metal Weight = 4.67 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
