BRIDAL SET – DIAMOND SET ENGAGEMENT RING AND WEDDING RING

Each ring is acid tested 9ct white gold.

Total weight: 6.38grams. Manufacture: Cast and hand finished.

Total diamond weight: 1.00ct.

Each ring is finger size "M and a half".

Engagement ring: 1 x four claw set diamond, surrounded lower by 12 x micropave set diamonds in a round halo; and with 44 x micropave set diamonds amongst the shoulders. Tapering half round band with upswept crossover shoulders that loop around the setting: 4-1.7mm wide.

Wedding ring: Featuring 25 x micropave set diamonds.

Tapering half round band: 1.9-1.6mm wide.

GEMSTONES

Diamonds – 1 x round brilliant cut, 4.2mm diameter x (est.)2.60mm deep*, G colour, I2 clarity, 0.28ct. *As an actual depth cannot be measured due to the constraints of the setting a 62% depth percentage has been applied to produce a calculated weight. The actual weight may vary.

56 x round brilliant cut, G-H colour, SI-I1 clarity, 12 x 1.0mm, 44 x 1.3mm, 56 = 0.50ct.

25 x round brilliant cut, 1.2mm, G-I colour range, SI-I1 clarity, 25 = 0.22ct.
