## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, hand-assembled, 9ct white gold, multistone, gem set ring.

Plain, narrow, tapered band of 2.00mm in width (at base) x 1.06mm depth, with open back (hollow) shoulders.

Feature central four claw setting, housing four round brilliant cut diamonds (largest), claw set, with one round brilliant cut diamond (smallest), claw set to the centre. Surrounded by sixteen round brilliant cut diamonds, larger to the corners, tapering in size to each side, also claw set. All secured between the extended shoulders of the plain and polished band.

Polished finish - stamped '375' - acid tested as 9 carat gold. Finger size is O 1/2.

The ring contains:

Four claw set round brilliant cut diamonds, clarity 'P1 & P2' (mixed), colour 'H to I' (mixed).  
Dimensions (average) = 2.30mm(Dia) x 1.40mm(D-estimated) x 2%(Girdle Thickness)  
Total Weight = 0.17ct (estimated - see NOTE below)

Seventeen claw set round brilliant cut diamonds, clarity 'P1 & P2' (mixed), colour 'H to I' (mixed).  
Dimensions = 1.40mm(Dia) x 0.85mm(D-estimated) x 2%(Girdle Thickness) (smallest)  
Dimensions = 1.60mm(Dia) x 0.98mm(D-estimated) x 2%(Girdle Thickness) (largest)  
Total Weight = 0.23ct (estimated - see NOTE below)

Total Item Weight = 2.50 grams - Total Gemstone Weight = 0.40ct - Total Metal Weight = 2.42 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
