Valuation for Traditional Retail Insurance Replacement

Item 1

One lady's, hand finished, raised, 10ct yellow gold & diamond set, cluster dress ring. Plain, narrow, low half round, tapered band, measures, with curved underrail, open back setting, underneath.

Feature, "cluster style" ring design, with shoulder & undercarriage stones. Comprising, a raised, square cushion shaped, cluster to top, houses twenty one round brilliant cut diamonds, various sizes, bead set. Drops to a surround, containing twenty four round brilliant cut diamonds, bead set. The extended shoulders, of the band tapers up to the top. Each shoulder splits to three rows, with two leaf shaped terminations, mill grain edges, Each shoulder contains seventeen round brilliant cut diamonds, bead set. The under carriage wall, having a bead set round brilliant cut diamond, each side.



Polished finish, stamped "10K, 2.00, michael hill" - acid tested approximately 10 carat gold. Finger size W.

The ring contains;

Nine bead set round brilliant cut diamonds, clarity is "Si & P1"(mixed), colour is "G to H"(mixed), medium cut quality.

Dimensions = 2.62mm (average diameter) x 1.60mm (D-estimated) (smallest)

Dimensions = 3.22mm (average diameter) x 1.96mm (D-estimated) (largest)

Total Weight = 0.90ct (estimated - see NOTE below).

Seventy Two bead set round brilliant cut diamonds, clarity is "Si & P1"(mixed), colour is "G to H"(mixed), medium cut quality.

Dimensions = 1.16mm (average diameter) x 0.71mm (D-estimated) (smallest)

Dimensions = 1.49mm (average diameter) x 0.91mm (D-estimated) (largest)

Total Weight = 1.10ct (estimated - see NOTE below).

Total Item Weight = 8.23 grams, Total Gemstone Weight = 2.00ct, Total Metal Weight = 7.83 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
