Valuation for Traditional Retail Insurance Replacement

Item 1

One, pair of lady's hand-assembled raised, 9ct yellow and white gold, diamond set, stud earrings.

Feature, cluster style" earring design. Comprising, a raised white gold centre, claw set. Drops to a three-comma mon design in yellow gold. open back with a central bar across the middle. Both with plain post & butterfly fittings attached.

Polished finish, stamped "9K" - acid tested both as 9 carat gold.

Earring dimensions = 8.52mm (L) x 8.49mm (W) x 3.83mm (D).

The earring contains:

- Fourteen claw set round brilliant cut diamonds, clarity is "Si", colour is "H to I"(mixed), medium cut quality.
- Dimensions = 1.49mm (average diameter) x 0.91mm (D-estimated) (smallest)
- Dimensions = 1.94mm (average diameter) x 1.18mm (D-estimated) (largest)
- Total Weight = 0.35ct (estimated - see NOTE below).

Total Item Weight = 1.74 grams, Total Gemstone Weight = 0.35ct, Total Metal Weight = 1.67 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar pair of cluster stud earrings, employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
