## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, 14ct rose gold, multistone, gem set ring, of cast construction.

Plain, narrow, tapered band of 1.83mm in width (at base) x 1.23mm depth, with hollow and open back settings, and shoulders.

Feature five round-shape, 'cluster' style ring design, housing a total of fifty round brilliant cut diamonds, tapering in size, claw set. All secured between the shoulders of the plain and polished band.

Polished finish - stamped '585 michael hill 0.64 TDW' - acid tested as 14 carat gold. Finger size is R.

### The ring contains:

Five claw set round brilliant cut diamonds, clarity is "SI-P1", colour is "G-H", medium cut quality.

Dimensions = 2.5mm(Dia) x 1.53mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.6mm(Dia) x 1.59mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.35ct calculated

Forty Five claw set round brilliant cut diamonds, clarity is "SI-P1", colour is "G-H", medium cut quality.

Dimensions = 1mm(Dia) x 0.61mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.1mm(Dia) x 0.67mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.29ct estimated

Total Item Weight = 2.60 grams - Total Gemstone Weight = 0.64ct - Total Metal Weight = 2.47 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only.
