Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct white gold, multistone, gem set ring, of cast construction.

Plain, narrow, tapered band of 2.17mm in width (at base) x 1.11mm depth, with hollow top and shoulders, and open back settings.

Feature 'cross-over' style design, consisting of seven baguette cut and tapered baguette cut (mixed), tapering in size, end set. Each shoulder having six round brilliant cut diamonds, also tapering in size, channel set.

Polished finish - stamped '375 GM16' - acid tested as 9 carat gold. Finger size is O 1/2.

The ring contains:

Seven end set baguette cut & tapered baguette cut (mixed) diamonds, clarity 'Si', colour 'J'.

Dimensions = 1.99mm(L) x 0.75mm(W) x 0.45mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.24mm(L) x 1.61mm(W) x 1.05mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.15ct (estimated - see NOTE below)

Twelve channel set round brilliant cut diamonds, clarity 'Si', colour 'J'.

Dimensions = 1.25mm(Dia) x 0.76mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.50mm(Dia) x 0.92mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.15ct (estimated - see NOTE below)

Total Item Weight = 2.91 grams - Total Gemstone Weight = 0.30ct - Total Metal Weight = 2.85 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
