One, platinum, diamond set, 'solitaire' style ring, of hand-assembled construction.

Plain, narrow, low half round band of 1.84mm width (at base) x 1.67mm depth, with an open back setting.

Feature central six claw setting, housing one round brilliant cut diamond, claw set. The setting is secured to the plain and polished band.

Stamped '33393318 D1.07CT C TIFFANY & Co. PT950' - acid tested as platinum.

The ring contains:

One claw set round brilliant cut diamond, clarity is "Vs1", colour is "G".

Dimensions = 6.64mm(L) x 6.62mm(W) x 4.04mm(D-estimated) x 1%(Girdle Thickness)

Total Weight = 1.07ct (estimated - see NOTE below)

Total Item Weight = 5.80 grams Total Gemstone Weight = 1.07ct Total Metal Weight = 5.59 grams (estimated)

NOTE: The diamond has also been laser inscribed upon the kite facet with T&Co. and P02180375. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The ring has a stamp of Tiffany & Co upon however, Tiffany in Melbourne will not assist with help in authenticating whether or not the ring is of their supply. Therefore, the below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
