Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, cluster style, gem set, dress ring, of cast construction.

Plain, narrow, tapered band of 1.90mm in width (at base) x 1.16mm depth, with a curved underrail, with cut-out sections.

Feature petal style, 'cluster' design setting, housing seven round brilliant cut diamonds, largest to the centre, claw set. Secured between the extended shoulders of the plain and polished band. Each shoulder having five round brilliant cut diamonds (smallest), bead set.

Polished finish - stamped '18CT MHJ .33 C' - acid tested as 18 carat gold. Finger size is N 1/2.

The ring contains:

Seven claw set round brilliant cut diamonds, clarity 'Si', colour 'I to J' (mixed).

Dimensions = 2.18mm(Dia) x 1.33mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.50mm(Dia) x 1.53mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.26ct (estimated - see NOTE below)

Ten bead set round brilliant cut diamonds, clarity 'Si', colour 'I to J' (mixed).

Dimensions (average) = 1.10mm(Dia) x 0.67mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.07ct (estimated - see NOTE below)

Total Item Weight = 3.49 grams - Total Gemstone Weight = 0.33ct - Total Metal Weight = 3.42 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
