Valuation for Traditional Retail Insurance Replacement

One, lady's hand finished, raised 10ct yellow and white gold & gemset cluster ring. Plain, narrow, low half round, tapered band, measures 1.96mm width (at base) x 1.04mm depth, with curved underrail, open back settings, underneath.

Feature, cluster style" ring design. Comprising, a raised white gold four claw setting to top. Drops to an oval-shaped surround, claw set. The extended shoulders, of the yellow gold band, tapers up to support the basket cluster on top, from both sides.

Polished finish, stamped "MHJ 10K" - acid tested approximately 10 carat gold. Finger size =



The ring contains;

One claw set oval-shaped, faceted, natural sapphire, colour is "black/blue". Dimensions = 7.97mm (L) x 6.06mm (W) x 3.78mm (D-estimated)

Total Weight = 1.49ct (estimated - see NOTE below).

Fourteen claw set round brilliant cut diamonds, clarity is "P1", colour is "I to J"(mixed), medium cut quality. Dimensions = 1.52mm (average diameter) x 0.93mm (D-estimated)

Total Weight = 0.18ct (estimated - see NOTE below).

Total Item Weight = 3.10 grams, Total Gemstone Weight = 1.67ct, Total Metal Weight = 2.77 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings.
