### Valuation for Traditional Retail Insurance Replacement

#### Item 1

One, hand-assembled, 18ct white gold, multistone, gem set ring.

Plain, narrow, tapered band of 2.04mm in width (at base) x 0.76mm depth.

Feature central four claw setting, housing one oval cut and faceted natural sapphire, claw set. To one side is six individual three claw settings, each claw set with one single cut diamond. To the opposite side is a curved 'leaf' design setting, bead set with three single cut diamonds.

Polished finish - stamped '18CT A&C' - acid tested as 18 carat gold. Finger size is O 1/2.

The ring contains:

One claw set mixed cut oval shape natural sapphire, colour 'dark blue'.  
Dimensions = 4.80mm(L) x 3.91mm(W) x 2.39mm(D-estimated)  
Total Weight = 0.35ct (estimated - see NOTE below)

Nine claw set & bead set (mixed) single cut diamonds, clarity 'Vs & Si' (mixed), colour 'G'.  
Dimensions = 1.60mm (ave. diameter)  
Total Weight = 0.15ct (estimated - see NOTE below)

Total Item Weight = 3.84 grams - Total Gemstone Weight = 0.50ct - Total Metal Weight = 3.74 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
