Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct white gold, multistone, gem set ring, of cast construction.

Plain, narrow, tapered band of 1.90mm in width (at base) x 0.96mm depth, with open back (cut-out) settings, and hollow shoulders.

Feature single row spanning across the top of the plain and polished band, housing twelve round brilliant cut diamonds, slightly tapering in size, channel set.

Polished finish.

Stamped '375 CG' - acid tested as 9 carat gold.

Finger size is O.

The ring contains:

Twelve channel set round brilliant cut diamonds, clarity 'Si & PI' (mixed), colour 'H to I' (mixed).
Dimensions (average) = 1.48mm(Dia) x 0.90mm(D-estimated) x 2%(Girdle Thickness)
Total Weight = 0.16ct (estimated - see NOTE below)

Total Item Weight = 1.81 grams
Total Gemstone Weight = 0.16ct
Total Metal Weight = 1.78 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings.
